Complete the registration form for Anytime Business and within days you will have access to your Ulster Bank accounts at your fingertips and you will be managing your business finances from the comfort of your own desk.

## Anytime Business Features

### 1. Account Servicing.

- **Balance Information.**
- **Account Activity** – shows transactions due to be applied to your account.
- **Transaction Details** – shows transactions of the last four months.
- **Transaction Search** – allows you to search for specific transactions on your account.
- **Transaction Download** – allows you to store statements electronically for your convenience.
- **Cheque/Credit Book Request.**
- **Standing Order View.**

### 2. Payment Services.

- **Pay bills** from your Ulster Bank accounts.
- **Inter Account Transfer** – transfers funds between your Ulster Bank accounts.
- **3rd Party Transfer** – sends funds to other domestic Financial Institutions.
- **Staff Payroll Module (max 50 staff).**
- **Beneficiary Maintenance** – add, amend, delete beneficiary details.

### 3. File Transfer

- **File Download** – enables you to download statement details produced for Ulster Bank's Reconciliation service.
